
CIRCULAR

SUBJECT: NOMINATION FOR 18TH MID CAREER MANAGEMENT COURSE (MCMC)
AT NIMS KARACHI, LAHORE, PESHAWAR QUETTA AND ISLAMABAD
W.E.F. 18-08-2014 TO 21-11-2014

18th Mid Career Management Course (MCMC) is scheduled to be held shortly. MCMC is made mandatory for promotion from BS-18 to BS-19. All Ministries / Divisions / Departments are, therefore, requested to nominate officers of BS-18 as per eligibility criteria for the upcoming MCMC. This Division would finalize a list of officers belonging to APUG (i.e. PAS, PSP & OMG), whereas, the nominations of officers belonging to other Occupational Groups / Services / Ex-Cadre Posts are to be forwarded by their controlling Ministries / Divisions. The nominations received directly from the attached Department / autonomous / Organizations shall not be entertained.

2. The following criteria is to be observed while nominating the officer(s):-

- i) Officer(s) is / are in BS-18 or equivalent on regular basis.
- ii) The Officer(s) is / are in the promotion zone.
- iii) The officer(s) may be considered in order of seniority in their respective cadres and the officers otherwise senior to them should not be ignored except on account of disciplinary proceeding (seniority list of the respective cadre may be supplied).
- iv) The officers, who are posted abroad, except those belonging to Foreign Services of Pakistan, may not be nominated.
- v) Officers on long leave / pending or undergoing disciplinary proceedings may also not be nominated.
- vi) Overall quantified score of PERs. Minimum threshold would be 60.

3. The nominating agencies are requested to forward following documents in respect of each nominees:-

- i) Latest Annual Medical Examination Report.
- ii) Panel Proforma duly filled in (Annex-I) & (Annex-II).
- iii) Certificate that no disciplinary proceedings are pending or going on under the Government Servants (Efficiency and Disciplinary) Rules, 1973 or any other court of law.
- iv) Copy of valid seniority list of officers in BS-18.

Important Requirements

- i) Proficiency in computer related skills has become a pre-requisite for successful operation of Mid Career Management Course (MCMC). Nominated officers, who are not computer literate, may be advised to immediately start working on computers so that they do not start the training with a handicap.
- ii) If the Officer so nominated for mandatory training declines to proceed on training for two consecutive training courses, then he / she would forfeit the right to be considered for promotion vide Establishment Division's O.M. No. 10/2/2009-CP-II (Pt-IX), dated 19-12-2011.
- iii) Those BS-18 officers who have attained the age of 50 years or may attain the same during the currency of the course are exempted from the training.
- iv) The subject course is mandatory for promotion; therefore, controlling Ministries / Divisions / Department will have to relieve the nominated officers.



4. The Course fee is Rs. 200,000/- per participant which covers expenses of boarding / lodging at NIMs' hostel and study tours. The Establishment Division will make payment of the course fee in respect of the officers belonging to Occupational Groups / Services. It is also informed that course fee of ex-cadre officers of Federal Government, officers of Provincial Governments and all officers other than those mentioned heretofore shall be paid by their respective organizations.

5. All nominations on the enclosed panel proforma along with complete documents must reach the Establishment Division (T-VI Section Room No. 2164) by 12-06-2014. It may kindly be noted that nominations not accommodated in previous course, shall not be considered automatically for this course unless sent as fresh cases.
