Statement of Government Authority

Please check with your government and/or the Netherlands embassy if this applies to your country. Fellowship applications from countries that require a government statement without an attached or uploaded government statement are considered not eligible and will not be further assessed for an NFP fellowship.

Paper fellowship application

Candidates need to have section 5 of the application form filled out, signed and stamped by the government authority concerned.

Online fellowship application

Candidates need to upload a government statement with their online fellowship application. Before submitting you can print your application for your own administration. You can use this print for the concerned the government authority in order to obtain a government statement. Candidates can use the format below.
